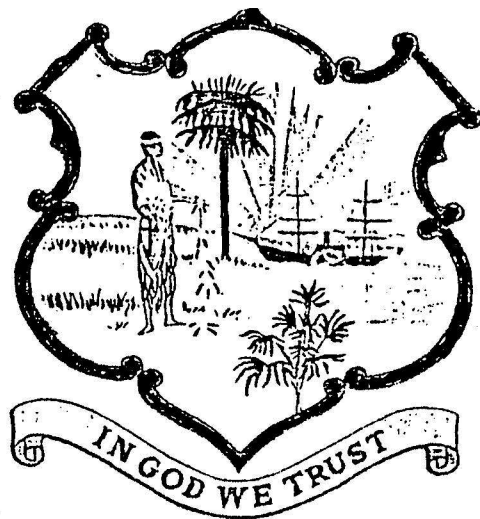

MUSTER ROLL OF CAPTAIN SAMUEL STEPHENS' COMPANY OF THE FIRST BRIGADE OF FLORIDA MILITIA ORDERED INTO SERVICE OF THE UNITED STATES BY R. K. CALL, GOVERNOR FROM THE 2ND DAY OF AUGUST TO THE THIRD DAY OF DECEMBER 1836.

The Company was mustered at Marianna, Florida by Col. L. Brown and dismissed by D. H. Vinton, Inspection & Mustering Officer at the same place on 6 March 1838.

Muster Roll of Captain Winston S. Stephens' Company in the First Regiment of Mounted Florida Volunteers, commanded by Col. Samuel St. G. Rogers, called into the service of the United States by the President under the Act of Congress approved May 13, 1846, from the 27th day of July 1857, the date of muster, for the term of six months unless sooner discharged.

The company was enrolled at Ocala, Florida, by Capt. W. S. Stephens and mustered into service 27 July 1857 by Lieut. S. D. Lee, 4th Artillery.

Muster Roll of Captain Winston Stephens' Company in the Regiment of Mounted Florida Volunteers, commanded by Col. Samuel W. George Rogers, called into service of the United States by Special Instructions from the President, dated War Department, Washington, May 25, 1857 at Ocala, Fla. (the place of general rendezvous) on the 27th day of July 1857 to serve for the term of six months from the date of enrollment unless sooner discharged - from the day of 27 July 1857 when enrolled to the 28th day of January 1858. The company was organized by Capt. W. Stephens at Ocala, Fla. in the month of July 1857.
